DOKOZA TIMELINE

For posterity's sake, here's some undeniable facts memorializing Dokoza's rise and fall timeline in bullets:

- September 28, 2010 Dokoza enters agency agreement with Lenhoff
- 2010–2014 Lenhoff on a tear triples Dokoza's income and books on A to Z, Baskets, Da Ali G Show, The Reporters, Girlfriend in a Coma, Up All Night
- February 8, 2014 Lenhoff books Dokoza on "A to Z" pilot episode with a series option
- March 8, 2011 Lenhoff introduces Dokoza to FX's Nick Lombardo & Matt Miegelecki
- January 15, 2014 Baskets pilot picked up
- March 7, 2014 Lenhoff pitches Dokoza to Blair Breard for Baskets
- 3/24/14 Dokoza contracts with "Baskets" pilot ONLY so as not to conflict with <u>"A to Z"</u>
- 3/24/14 Dokoza discuss doing Baskets series in May 2015 Gotcha e-mail
- 4/30/14 to 12/15/14 Lenhoff send UTA monthly notices of client list <u>including</u>
 <u>Dokoza and terms</u>.
- April May 23, 2014 Dokoza produces the Baskets pilot episode
- April 30, 2014 Lenhoff sends 1st dispute notice to UTA noticing exclusive client list and terms
- O/a May 15, 2014 Dokoza's "A to Z" series option is picked up and she commences <u>exclusive services</u>

- June 9, 2014 Lenhoff sends 2nd dispute notice to UTA noticing exclusive client list and terms
- July 14, 2014 Lenhoff sends 3rd dispute notice to UTA noticing exclusive client list and terms
- July 24, 2014 Dokoza delivers a Baskets <u>series budget</u> to Blair Breard, Nick Lombardo and Matt Magielnicki @ FX (while working on A to Z)
- July 25, 2014 Magielnicki sends Scott Frimmer @ FX Business Affairs the Dokoza 7/25/14 budget (he starts working off that budget and making deals)
- 7/29/14 & 7/30/14 Lenhoff receives offer for Dokoza to produce "Baskets" series from Blair Breard – offer is contingent on Dokoza's availability – Lenhoff discusses offer with Dokoza and scheduling issue
- August 15, 2014 Lenhoff sends 3rd dispute notice to UTA noticing exclusive client list and terms
- August 27, 2014 Baskets series is picked up
- September 2014 Lenhoff successfully gets Dokoza into the DGA union.
- September 16, 2014 Lenhoff sends 4th dispute notice to UTA noticing exclusive client list and terms
- October 13, 2014 Andrew Singer emails Lenhoff that he wants to hire Dokoza for the HBO pilot reshoot
- October 14, 2014 Blair Breard tells Lenhoff she is waiting for a locked series budget before closing Dokoza's series deal.
- October 16, 2014 Lenhoff sends 5th dispute notice to UTA noticing exclusive client list and terms

- October 22, 2014 Dokoza discuss doing "A To Z" back 9, "Brothers In Atlanta" pilot reshoot and "Baskets series in May 2015 – Gotcha e-mail
- October 29, 2014 Lenhoff starts negotiating Brother's In Atlanta pilot reshoot with Susan Goldberg @ HBO. Goldberg @ HBO makes offer for Dokoza to produce "Brothers In Atlanta" pilot reshoot with series option <u>behind the</u> "Baskets" series
- October 29, 2014 Frimmer sends the Dokoza 7/25/14 Baskets series budget to Suresh Seeram in FX accounting (presumable to start the series cash flow)
- October 21, 2014 "Brothers In Atlanta" pilot reshoot casting breakdown goes out
- October 31, 2014 A to Z cancelled
- November 4, 2014 11/4/14 Dokoza dismisses L&L while working on "A To Z" and negotiating 2 other deals for "Brothers In Atlanta" and "Baskets"
- November 5, 2014 Lenhoff sends the "72 Hours" letter to Dokoza as required under Title 8 California Code Of Regulation 12002 claiming commissions to 3 shows: "A to Z," "Brothers In Atlanta" and "Baskets
- o/a November 12, 2014 Dokoza retains UTA
- November 18, 2014 Lenhoff sends 5th dispute notice to UTA noticing exclusive client list and terms
- January 7, 2015 Dokoza's receives final payment for work performed on "A To Z"
- January 22, 2015 Dokoza starts work on Brothers In Atlanta pilot reshoot Lisa Lenhoff e-mails her a check authorization

- January 30, 2015 UTA sends Lenhoff a fuck you and piss off letter. In discovery, UTA curiously labels it as "Anna Dokoza – Protection Letter".
- February 4, 2015 Lenhoff assigns Dokoza debt to Silverman
- February 13, 2015 Lenhoff vs. UTA & ICM federal complaint filed
- June 4, 2015 Silverman files suit against Dokoza and spends over 5 months trying to get Dokoza to settle the matter
- July 7, 2015 Dokoza asks Baskets to issue 1st check for \$7500 but is delayed because of insurance issues at FX
- July 31, 2015 Dokoza issued the 1st Baskets series payroll check
- August 11, 2015 Lenhoff receives Dokoza's 1st Baskets check for \$6975 for w/e
 7/31 and deposits it into Dokoza's agency trust account
- o/a August 14, 2015 "Baskets" accountant Emily Rice calls Lisa Lenhoff "It's my fault and I hate when this happens because I'm going to have to reissue Dokoza a replacement check". We refer her to Arden Silverman
- August 14, 2015 Dokoza is reissued 3 Baskets checks for \$2325 for w/e 7/17, 7/24 and 7/31
- October 24, 2015 Dokoza served Silverman's LASC complaint
- November 24, 2015 UTA hires lawyers @ Freedman & Taitelman to represent
 Dokoza requests a week extension from Silverman
- December 1, 2015 Dokoza files cross complaint against L&L (box #13 of related cases is checked "no" which is a flat out lie to the LA Superior <u>court</u>)

- December 3, 2015 Lenhoff deposits \$6975 of Baskets money into Dokoza's account
- o/a December 4th, 2015 Lenhoff is served the Dokoza LASC complaint
- December 4, 2015 Silverman attempts to propound discovery on Dokoza:
 - Request For Document Production
 - Special Interrogatories
 - Form Interrogatories
 - Notice of Taking of Deposition of Dokoza
- December 7, 2015 Dokoza files a LASC motion to stay proceedings, memorandum of points of authorities in support thereof, declaration of Marmorstein
- January 4, 2016 Dokoza petitions the Labor Commissioner to determine the controversy (misrepresenting a theft, breach our fiduciary duty, violation of the TAA, etc.)
- January 4, 2016 Dokoza files LASC motions to object all DISCO, FROGS, DEPO
- January 5, 2016 John Kalajian retained
- January 8, 2016 Kalajian files a general denial in LASC
- January 22, 2016 Kalajian files an admission & denial response with Labor Commissioner
- January 29, 2016 Kalajian attempts to propound discovery on Dokoza and UTA with the following:

- March 28, 2016 Kalajian files response with Labor Commissioner that Dokoza is not an "artist"
- April 8, 2016 Kalajian files motion with Labor Commissioner to dismiss or bifurcate affirmative defense of lack of jurisdiction
- April 11, 2016 Kalajian issues subpoena requests with Labor Commissioner for Blair Breard, Matt Magielnicki, Andrew Singer, Susan Goldberg

- May 1, 2016 Dokoza files opposition motion to dismiss with Labor Commissioner
- May 4, 2016 Kalajian files motion for judicial notice with Labor Commissioner
- May 5, 2016 Jackman @ Labor Commission notices hearing continuance
- May 12, 2016 Marmorstein sends letter to Labor Commissioner objecting to subpoenas request and demands a briefing schedule
- May 17, 2016 Jackman sends notice of telephonic hearing on motion to quash issuance of subpoenas
- May 25, 2016 Dokoza files motion to quash subpoenas with Labor Commission
- June 3, 2016 Kalajian files opposition to motion to quash subpoenas with Labor Commissioner

- September 20, 2016 Dokoza files opposition motion for leave to file cross complaint with LASC
- September 21, 2016 Kalajian files reply to opposition to motion in limine with Labor commissioner

- September 26, 2016 Kalajian files Lenhoff declaration in support for motion to dismiss with Labor Commissioner

- January 4, 2017 Kalajian is granted motion to be relieved by LASC
- January 5, 2017 Dokoza send notice to LASCL of the Labor Commissioner's decision
- January 5, 2017 Dokoza sends notice of court's ruling and status conference to LASC
- January 27, 2017 Charnley sends notice of attorney substitution to LASC
- February 1, 2017 Dokoza propounds discovery on Lenhoff
- February 21, 2017 Dokoza sends LASC notice of defendant's answer to complaint

- January 24, 2018 Dokoza deposes Lenhoff
- February 20, 2018 Dokoza files complaint against Lenhoff with the DGA and sees Arbitration.
- February 22, 2018 Lenhoff deposes Emily Rice
- February 26, 2018 Lenhoff deposes Dokoza
- March 22, 2018 Dokoza agrees to drop all DGA claims against Lenhoff, and expunge all former claims on the record against Lenhoff with the California Labor Commissioner.
- April 19, 2018 Lenhoff files ethics complaint with Tom Lills @ California State
 Bar against Dokoza's lawyers BRYAN FREEDMAN & DAVID MARMORSTEIN

- May 2018 Dokoza's lawyer offers Lenhoff \$10,000 to settle dispute Lenhoff politely but firmly declines believing someday in the future, Dokoza will fess up and pay the \$200,000 in commissions owed plus 10% simple annual interest.
- May 18, 2018 Lenhoff and Dokoza file Requests For Dismissal with the LA Superior Court
